

Tribute to Late Prof. Neeru Nakra on her 3rd Death Anniversary

Three years have passed since we bid farewell to our beloved Prof. Dr. Neeru Nakra on 28th April, 2021. She was a distinguished scholar, a passionate teacher, and a kind mentor to many students and colleagues. She has left an indelible mark on our lives. She had a long and illustrious career in law, teaching at various institutions including Delhi University and Vivekananda Institute of Professional Studies. Her enthusiasm for Intellectual Property Rights was infectious, igniting curiosity that continues to burn bright in her absence. Her impact extended far beyond the bounds of academia, touching the lives of all who had the privilege of knowing her. Today as we reflect on her life and contributions, we dedicate this segment on Intellectual Property Law, to her.



26 April: World Intellectual Property Day

Annually observed on April 26th, World Intellectual Property Day was established by the World Intellectual Property Organization (WIPO) in 2000. Its purpose is to raise awareness about the impact of patents, copyright, trademarks, and designs on daily life. Additionally, it

celebrates the creativity and contributions of creators and innovators to global economies and societies. April 26th was selected for this occasion because it marks the date when the Convention Establishing the World Intellectual Property Organization came into effect in 1970. World Intellectual Property Day stands as WIPO's foremost intellectual property (IP) public outreach campaign. Below are some amazing facts about Intellectual Property Rights:

- 1. The oldest known patent was granted in Venice, Italy in 1474 to a glassmaker named Antonio da Pisa. This patent protected his invention of a method for making glass.
- 2. Coca-Cola's recipe is one of the most closely guarded trade secrets in the world. It's locked away in a vault in Atlanta, Georgia, and only a handful of people have access to it.
- 3. Tiffany & Co. has trademarked its signature blue color known as "Tiffany Blue." This unique shade of blue is protected as a trademark and can only be used by the company.

The right to be free from adverse effects of climate change recognized by Supreme

Supreme Court recognized the right to be free from the harmful effects of climate change, finding that it is inextricably linked to the right to life and equality guaranteed by the Indian constitution, and has overturned a 2021 ban on overhead powerlines covering 99,000 square km to protect the Great India Bustard on the ground that such lines would significantly impact the country's clean energy transition, endangering fundamental rights to life, equality, and energy access.

Under the Consumer Protection Act, 1986 commercial disputes cannot be decided in summary proceedings: Supreme Court

The Supreme Court determined that business disputes cannot be handled in quick proceedings under the Consumer Protection Act,1986. The court affirmed the State Consumer Disputes Redressal Commission (SCDRC) and District Consumer Disputes Redressal Forum (DCDRF) orders, allowing the complainant's case to be maintained. The court determined that the investment was for profit/gain and hence did not fall within the 1986 Act's provisions in the case of *Annapurna B. Uppin & Ors.* v. *Malsiddappa & Anr*.

Supreme Court held the Regulations set by the University Grants Commission (UGC) must be 'adhered to' by universities

The Supreme Court has directed Jamia Millia Islamia University (JMIU) to restore instructors who were refused regularization after the University Grants Commission (UGC) recommended it. The court ruled that JMIU should have allowed instructors to stay in their positions, rather than restarting the selection process. The court also highlighted the binding effect of UGC Regulations on institutions, requiring universities to adopt their recommendations.

Trailers don't create contractual relationships between filmmakers & consumers: Supreme Court

The Supreme Court ruled that a promotional trailer does not establish a contractual connection between a producer and a customer, despite allegations of unfair trade practices against Yash Raj Private Limited for not including the 'Jabra Fan' song in the movie Fan. The court rejected the claim that excluding content from a promotional video constitutes a 'deficiency of service' or unfair trade conduct. The court also stated that a promotional film is not an offer and cannot be converted into a commitment or contract.

Supreme Court directed the government of Himachal Pradesh to review its policies on Child Care Leaves (CCL) concerning working mothers

The Apex Court has directed the Himachal Pradesh government to review the issuance of Child Care Leave to Mothers, including developing measures under the Rights of Persons with Disabilities Act (RPWD Act) for mothers raising special needs children. The court emphasized that Child Care Leave supports women's equal participation in labor and that the state cannot ignore the unique difficulties women with exceptional needs face. A committee was formed to examine the case, including the State Commissioner, Women and Child Development, and Social Welfare Departments.

Supreme Court reiterates that Stridhan is women's absolute right

The Supreme Court ruled that a husband has no control over his wife's stridhan property and has a moral responsibility to return it. The court ordered the husband to pay 25 lakhs in compensation for his wife's allegedly stolen wedding jewels. Critics criticized the judgment as "legally unsustainable" and criticized the approach required for proof. The court deemed the award appropriate in the interest of equity and justice.

International Legal News

ICJ orders Israel to allow food and medical aid into Gaza

In a unanimous decision, the International Court of Justice (ICJ) said Israel had to act "without delay" to allow the "provision of urgently needed basic services and humanitarian assistance." The ruling comes after a report by the Integrated Food Security Phase Classification Global Initiative, which is run by the World Food Programme and others, was published last week - warning that a "catastrophic" situation was developing in Gaza.

Nicaragua raises claims against Germany at the ICJ for its support of Israeli 'Genocide' in Gaza

Germany is facing charges at the ICJ for allegedly "facilitating the commission of genocide" against Palestinians in Gaza in coordination with its military and political ally, Israel. Nicaragua presented its case before the ICJ, demanding judges impose emergency measures to stop Berlin from providing Israel with weapons and other assistance and to decide "provisional measures" – emergency orders imposed while the court considers the broader case.

Mexico filed a complaint in the ICJ against Ecuador for breach of asylum laws

Post the event when Ecuadorian authorities forced their way into the Mexican diplomatic mission to arrest Ecuador's former Vice President Jorge Glas who had been seeking asylum in Mexico, Mexico has filed a complaint at the ICJ asking the U.N. to expel Ecuador. The use of force and illegal incursion into a diplomatic mission by the Ecuadorian forces would set a precedent that the ICJ has been tasked with resolving. Mexico, as well as public international law experts say it appeared to be a violation of international accords.

ECHR Condemns Systematic Human Rights Violations by Russian-Controlled Forces in Georgia's Occupied Regions

The European Court of Human Rights (ECHR) has delivered a unanimous verdict declaring that Russian-controlled forces in Georgia's occupied regions have systematically violated human rights. The ECHR identified serious breaches of multiple articles of the European Convention on Human Rights. These included fundamental rights such as the right to life, prohibition of inhuman or degrading treatment, right to liberty and security, right to respect for private and family life, protection of property, right to education, and freedom of movement. The Commission held that the incidents of human rights violations were not isolated but constituted a pattern or system of abuse.

ECHR holds Switzerland in breach of Human Rights Convention for climate inaction

The European Court of Human Rights found Switzerland in breach of Article 8 and Article 6 of the European Convention on Human Rights. These articles guarantee the right to respect for private and family life and access to the Court system, respectively. The Court stated that the State must adopt and implement effective measures to mitigate climate change's adverse effects. The ECHR held that Switzerland had breached its obligations under the Convention by not taking sufficient action to mitigate climate change. The court highlighted critical gaps in Switzerland's domestic regulatory framework, including the failure to quantify national greenhouse gas emissions limitations and meet past emission reduction targets.

Lebanon moves towards accepting ICC jurisdiction for War Crimes on its territory

Lebanon has moved towards accepting the International Criminal Court's jurisdiction to prosecute violations on Lebanese territory. It has accused Israel of repeatedly violating its sovereignty and committing breaches of international law over the last six months, during which the Israeli military and Lebanese armed group Hezbollah have traded fire across Lebanon's southern border in parallel with the Gaza War. Neither Lebanon nor Israel are members of the ICC, which is based in The Hague. However, filing a declaration to the court would grant it jurisdiction to investigate and prosecute relevant crimes in a particular period.
